### OVERVIEW

Matthew will always fight for his clients. He is a seasoned trial and appellate advocate, seen appearing before the Supreme Court in the most recent landmark judgments in his field. Matthew's cases here and abroad, span company, insolvency, trust and commercial disputes. Amongst his current varied workload are two multi-million claims in the Commercial Court, but he brings the same dedication and attention to detail to every single instruction. Matthew has over 150 reported cases to his name.

#### COMMERCIAL LITIGATION & ARBITRATION

Matthew's current caseload embraces three multi-million claims including two class actions: one arising from the failed eclipse film finance scheme; the other concerning property development and involving extensive interlocutory relief: **4VVV v Spence** [2022] EWCA Civ 500 and [2023] EWMCI (Comm)

#### CIVIL FRAUD

Matthew has conducted numerous high profile civil fraud cases, including two in the Supreme Court: **FHR v Mankarious** on constructive trusts, and **Patel v Mirza** on illegality - the most significant authority on civil fraud for decades, with a five person panel of justices. Matthew has recently secured a significant victory in the Court of Appeal in a £70m conspiracy claim **Maranello Rosso Ltd v Lohomij** EWCA CV 1667.

## COMPANY & PARTNERSHIP

Matthew has long specialised in company law, and appeared in the Supreme Court in **Progress Property v Moore** on unlawful distributions. He has fought dozens of shareholder disputes, and he successfully defended the recent directors from a multi million claim for breach of fiduciary duty in **TMD v Yeo** [2021] EWMC 2033 CH.

## INSOLVENCY & ASSET RECOVERY

Matthew has featured in most of the significant insolvencies during his career including appearing in the House of Lords in Arrows and Atlantic Computers. Recent high profile instructions include London Capital & Finance and Greensill Bank. A recent Court of Appeal appearance of Matthew's explored the assignment of insolvency claims to litigation funders: **Edengate** [2022] EWCA Civ 626

## OFFSHORE & TRUSTS

Matthew's case **Denaxe v Cooper** [2022] 4 WLR 52 provides the Court of Appeal with its first opportunity to review the courts jurisdiction to bless transactions by trustees and others. In the high profile London Capital v Finance Insolvency, Matthew successfully removed security trustees: [2020 EWMC 597(ch).

Matthew regularly deploys his expertise in his specialist fields aboard, and has been called to the Bar in the BVI, Cayman and Bermuda. He has acted in many trials and appeals (up to the Privy Council), and has appeared in tribunals in jurisdictions as diverse as Milan and Reykjavik.
