## OVERVIEW

He then read Law with 'Senior Status' (i.e. as a second undergraduate degree) at Harris Manchester College, Oxford, graduating top of the Senior Status course. He subsequently completed the Bar Course with Distinction, receiving the Derek Wood QC Prize for the best overall performance at the Inns of Court College of Advocacy.

Together with Professor Robert Hazell (Constitution Unit, UCL), Timothy is co-author of *Executive Power: The Prerogative Past, Present and Future* (Hart Publishing, 2022). The book examines the prerogative powers of the Crown amid the changing landscape of the British constitution.
